The Consultant hired would support the company in the development of Land Management Projects, on the design and implementation of activities that requires indigenous people and traditional communities (IPLC) engagement, following the principles and guidelines stablished by existing international law and best practice international standards frameworks, in particular the UN Guiding Principles on Business and Human Rights (UNGPs), the UN Declaration on the Rights of Indigenous Peoples, the OECD Guidelines for Multinational Enterprises on Responsible Business Conduct and the Convention on Biological Diversity - Global Biodiversity Framework, as well as relevant voluntary guidelines. As required by the main carbon project certification entities.

#### Consultancy activities

Consultancy activities would include, but are not limited to:



- 1) Development of socioeconomic assessments.
- 2) Development impact assessment, related to the implementation of project's activities, on resources identified as important to IPLC; include the identification of risks and mitigation measures related. Risks may include trade-offs with food security, land loss, loss of yields, negative impacts on livelihoods, and climate change adaptation, as well as risks related to the safety of women and girls, children, and minority and marginalized groups within the local communities.
- 3) Support the design of a Benefit-sharing Plans.
- 4) Support the design and facilitate the activities related to local stakeholders' consultations, in a manner that is inclusive, culturally appropriate, and respectful of local knowledge, as part of a free, prior, and informed consent (FPIC) process¹. Collect, synthesis, store and report on all data that outlines the FPIC process and consent outcomes.
- 5) Support the development of a grievance redress procedure to address disputes with IPLC that may arise during project planning and implementation, including with regard to benefit sharing, taking into account culturally appropriate conflict resolution methods.

- A minimum of three years of professional experience in Land Management projects with IPLC.
